
Specification

1. **Should be wall mount installation type**
2. **Should contain** Digital advance alert system, Purity indicator and TDS Modulator
3. Purifier's body should be made with food safe and non-toxic plastics that comes with the dimension of H 486 x W 360 x D 311 mm and weight less than 10 kg.
4. The purifier should have 10 liters storage capacity along with the flow rate of up to 9 to 12 liters per hour.
5. The unit should be able to purify hard water of 2000 ppm TDS.
6. Should provide two germs killing kits, it should have digital advance alert system alarms 15 days prior for kit's replacement.
7. The purification with 6 stage purifying process with 100% RO and UV filtered water.
8. Purification technology should contain pre-sediment filter, pre-RO carbon filter, post-carbon sediment filter, reverse osmosis membrane, UV reactor and post-RO carbon filter.
9. The Reverse Osmosis process should remove insoluble impurities like pesticides, fluorides and undesirable salts.
10. The water purifier should be protected from voltage fluctuations.
11. Purifier that comply stringent US EPA norms for safe drinking water.
12. AMC for three years shall be included in the quote

Terms and conditions

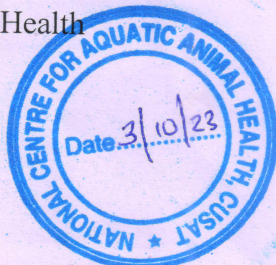
1. The Centre has the right to reject any quotation without assigning any reason.
